#### Who Should Apply?

Any GRIP Retro member with:

- zero DOSH violations or other serious infractions in the past (3) three years and in the current application year.
- an OSHA recordable claim frequency below the Washington State industry average for the most current OSHA log.
- zero time loss claims in the current plan year.
- an Experience Modification Rating (EMR) below 1.0.

#### How to Apply?

- 1. Complete and sign the GRIP on Safety Excellence Award application form and attach the following documentation:
  - o a copy of your most recent OSHA 300A Summary Report.
  - o a screenshot or documentation of your current EMR.
- 2. Send application and required documentation to <u>safety@ernwest.com</u> before the given deadline.

# **Frequently Asked Questions**

- 1. Who on our team should complete and submit the application form? GRIP encourages each company to engage as many employees as possible in the process. Consider using operations, human resources, safety managers, or safety committee members and employees in the process.
- 2. What documentation is needed for applications to be accepted? Candidates for the GRIP on Safety Excellence Award must submit the following documents as part of their application packet:
  - a completed GRIP on Safety Excellence Application Form.
  - a copy of your most recent OSHA 300A Summary Report Form.
  - a screenshot or copy of your most recent experience modification rating (EMR) showing your most recent EMR.

- 3. Where do I submit my application with documentation? Applications and documentation must be submitted to <u>safety@ernwest.com</u> by the deadline.
- 4. Will completing the application prevent me from a DOSH Compliance Citation? No, completing an application will not guarantee a citation-free DOSH visit.
- 5. What should I do if I do not know my North American Industrial Classification Code System (NAICS) code or do not see my Industry listed? Contact ERNwest at <u>safety@ernwest.com</u>. They can assist.
- 6. **How do I calculate my frequency rate?** Frequency rate can be calculated by the # of OSHA recordable injuries x 200,000/total manhours worked or go to the BLS Incident Rate Calculator and Comparison Tool online. (https://data.bls.gov/iirc/)
- 7. Who will review application forms and submissions? The program administrator will review all applications forms.
- 8. Will our EMR decrease if we complete an application? No. However, companies who do actively participate are more than likely to have lower insurance and workers' compensation costs.
- 9. Is the information submitted in the application confidential? Yes, the information contained in each application form is viewed only by the program administrator and is kept confidential.
